



Though convention does not officially start until Thursday, please come early for a special reception and historical presentation at the Greenwood Cultural Center on Wednesday, August 4th. The center is located in the heart Tulsa's Greenwood District, a historic district that was dubbed America's "Black Wall Street" in the early 1900s. This year marks 100 years since the infamous Tulsa Race Massacre that destroyed this once prosperous African-American community in just a few days. Thanks to generous alumni donations, we would like to invite all convention attendees and their guests to join us at a reception to learn more about the history of this district and to celebrate the continued prosperity of the community on this somber 100-year anniversary.

Student Voting Delegates

Each student senate is required to send a voting delegate to the convention. For that delegate, the fraternity will cover the cost of lodging, not including incidentals, and reimburse transportation costs up to \$350. Each senate will need to cover the convention registration fee for their voting delegate and any transportation costs above the designated amount, unless the additional amount is approved by the Convention Committee prior to convention. Registration costs cover most meals. For any additional non-voting students, the student or their senate would need to cover all registration, lodging, and transportation costs.

Student senates should contact Executive Director Penney Edgar as soon as possible for additional details about registration, lodging and transportation. The fraternity will arrange lodging for each student.

Dress attire for convention is business casual, and the Chancellor's Ball is 1980's attire for the Totally 80's,

Totally Murder Mystery Dinner. Remember to bring business attire if you plan to get head shots taken with the convention photographer.

Running For The Supreme Senate

This group will be charged with conducting the business of the fraternity and performing the duties of their office in accordance with the Delta Theta Phi Constitution for the next two years.

Any member interested in running for office will have plenty of opportunities to network with the student and alumni delegates during convention activities and in the hospitality suite. Be sure to talk with the other delegates about what your senate has been doing in the last year and work to find those delegates that will "stand up" for you during elections.

Any resumes received by August 1st will be included in the electronic materials that each delegate receives at registration. Resumes received after that date will be handed out as received to the voting delegates.

Student Awards At Convention

Student delegates attending the convention may be considered for any the following convention awards:

WILLIAM H. THOMAS AWARD FOR ORAL ADVOCACY

This award is presented to the student delegates who, in making their reports at the biennial convention, demonstrate the highest excellence in oral advocacy. They are judged upon the overall effectiveness of their five minute presentations, including outlook, logic, and matters of significance to the Fraternity, both locally and internationally. There are cash awards for first, second, and third place who are selected by a special committee appointed by the Chancellor at convention. All student delegates must make a short report for official records.

JOSEPH M. PERRY, JR. AWARD FOR PARLIAMENTARY ADVOCACY

This award was established by a trust endowed in memory of Margaret Depp Benzinger and managed by the Delta Theta Phi Foundation. It provides awards at the biennial conventions to students who best exemplify the art of oral advocacy in the parliamentary proceedings. Student delegates are observed throughout the course of the convention for their advocacy skills.

ROBERT J. COLE, JR. SCHOLARSHIP

The Robert Cole Scholarship, established in 2003 by a gift of Mrs. Robert L. (Frances) Cole, Jr., is awarded to that student delegate that exhibits those professional qualities demanded by the fraternity as described in the Delta Theta Phi Constitution, Ritual of Initiation, and those expected by current and future colleagues in the practice of law and its related fields. A committee comprised of one Past Chancellor, the current Chancellor, and current Master Scholar shall observe and inquire about delegate behavior including dress, speech, demonstration of respect, and general behavior in general assembly, workshops, and social situations throughout the duration of the convention. There is no need to apply for this award. Every voting and non-voting student delegate to the biennial convention is automatically eligible.

And, don't forget the "You Know Why!" Award! If you don't know that that means, then you'll just have to come to Tulsa to figure it out.

Preparing For the Thomas Competition

During convention, all student delegates will automatically be entered into the William H.

Thomas Oral Advocacy Competition. They will give a five-minute pre-

sentation reporting on their senate. Each delegate may prepare packets to supplement their presentation, but this is not a requirement. Prior competition winners have been successful whether they prepared additional information or just gave a speech.

The competition will run in two phases where winners will be selected based on who is the best advocate for their senate, not on which senate has done the most. During the first phase, each delegate will give their presentation in a smaller room for an alumni panel and only a few students. The winners will advance to the second phase and make a presentation to the entire International Senate. The three best presenters will be awarded a cash prize.

Although students will have some time during convention to put together their presentations, each should come to Tulsa with a basic idea or plan for their speech. Be sure to start writing down what your senate accomplished this year, what makes your senate special, and why you love being a Delt. And, feel free to reach out to the members of the Supreme Senate if you have any questions about the competition.

We are really looking forward to hearing from everyone at this year's convention!

Submission of Constitutional Amendments

Where Can It Take You?

In November of 1981, as a first year law student, I recall an upperclassman telling me about an organization called Delta Theta Phi. Nearly forty years later, I am a proud Past Chancellor of this wonderful fraternity. Below are some interesting stories for those years in between.

During law school, besides the study assistance and the parties of course, Delta Theta Phi brought me a closer relationship with my professors, the law school administration and my fellow classmates. Delta Theta Phi took

me and three of my fellow officers in a car, for many hours, from San Diego, California to Dallas, Texas for our first convention. Yes, that was an experience. As you ask any brother or sister who is now an alumni member of Delta Theta Phi, I guarantee you that they will be able to share some very interesting and memorable stories about their law school days at a Delta event.

Where else can it take you? The conventions. Whether it be by train, plane or automobile, Delta Theta Phi gives everyone an opportunity every two years to attend four fun-filled days at an exotic location chosen especially for you. This year, the Delts will converge on Tulsa, Oklahoma. At the conventions, the opportunities for learning and leadership are limitless, not to mention all the libations. There are competitions

and scholarships awarded at the convention. Some of the most invaluable resources, however, that were provided at the convention are the relationships that are developed. The members of our Supreme Court and our Supreme Senate are distinguished leaders in the community, business and law. Our alumni members are judges and elected officials all over the country. The student delegates will come to be your colleagues in the practice of law, and the source of business referrals and legal knowledge.

At the past conventions, I met friends I have known for over three decades, attorneys who have referred me business, and attorneys I have referred business to. It is very impressive to a colleague or a potential client when you represent, that you have a connection to a national resource of attorneys

in every field all over the country. A simple call or email to our Executive Director will provide you that resource.

Business contacts are not the only benefit achieved at the convention. At my first convention as a New Yorker who moved to San Diego and drove to Texas, I met an alumnus from Minnesota, who a year later flew to San Diego as one of my groomsmen at my wedding. (Some delegates who practice and first meet at the convention, now report many years of marital bliss.) At that same convention, I met an alumnus from Virginia, who fifteen years later sponsored me, and personally moved my admission to the United State Supreme Court.

Following that admission ceremony, where I was the only attorney whose admission was moved that day, before seven of the nine justices of the Supreme Court (I must say an awesome experience), I was shooting hoops with a fellow brother who happened to be the Clerk of the United States Supreme Court, on the highest court in the land, on the top of the Supreme Court building. None of that would have happened but for my membership and involvement with Delta Theta Phi.

Where will it take *you*? To Laramie, Wyoming and then to Mt. Rushmore? To a permanent job in San Diego after graduating from North Carolina? To the secret handshake in a judge's chamber's unknown by opposing counsel? To working at an alumni's office during law school? These are places Delta Theta Phi has taken me and allowed me to take others. In the next issue of the Paperbook, I look forward to reading where it has taken you.

Delta Theta Phi Scholarship Key

In addition to the annual awards, any member of the Fraternity in good standing may earn a Scholarship Certificate and the right to wear the Delta Theta Phi Scholarship Key if he/she:

- Has received an LL.B. or J.D. degree and has attained an average scholarship standing during his/her entire law course among the highest 15 percent of all the members of his/her graduating class; or
- Has completed his/her 2L year and has attained an average scholarship standing up to and including his/her junior year among the highest 7 1/2 percent of all the members of his/her class, or;
- Is a 3L with a G.P.A. of 3.00 or better, or letter grade of “B” or better, or other numerical equivalent as determined by his/her law school.



Members wishing to apply for the Scholarship Certificate and/or Key should contact the Master Scholar (at masterscholar@deltathetaphi.org) for the appropriate form. A certificate is ordered for all who meet or exceed the above-referenced requirements and is suitable for framing. The scholarship key is available “at cost” to the member, currently a cost of approximately \$65.

Remembering Brother Joe Spurlock

In addition to being a loyal member of Delta Theta Phi, the Honorable Joseph Spurlock II was a titan of the legal in community in Texas, with his influence stretching all the way to Mongolia, where he assisted with judicial reform. It was an honor a privilege to know and serve with Joe, we will always remember him.

In memory his great accomplishments, the following Resolution of Respect from the Supreme Senate of Delta Theta Phi Law Fraternity, International was read during Brother Spurlock's public remembrance.

Resolution of Respect in Loving Memory of Judge Joe Spurlock II our Beloved Brother in Delta Theta Phi

We, the Supreme Senate of Delta Theta Phi, Law Fraternity International, brothers and sisters of Judge Joe Spurlock II, want his family to know that we mourn with you the passing of a great man. Judge Joe Spurlock II an advocate, professor, and community leader contributed so much not only to our wonderful Fraternity but the legal community as a whole and we wish to express our gratitude and respect for all that Judge Joe Spurlock II did for our betterment.


Whereas, Judge Joe Spurlock II was a respectful and reverent native Texan, whose appearance was always accentuated by his cowboy hat and boots, a true southern gentleman that demonstrated propriety and decorum in all that he did; and

Whereas, Judge Joe Spurlock II was a dedicated Delta Theta Phi member since 1961, was bestowed

Member Emeritus status for over 35 years of continuous membership and service, and honorably elected to the Fraternity's Supreme Court serving as an Associate Justice providing judicial assistance from 2015 to 2020; and

Whereas, Judge Joe Spurlock II was committed to upholding the object of Delta Theta Phi, uniting congenial students of the law, leading them to high scholarship and legal learning, surrounding them with an environment such that the traditions of the law and of the profession may descend upon them, promoting justice, inspiring respect for the noblest qualities of mankind and advancing the interests of affiliated colleges of law, and .

Whereas, Judge Joe Spurlock II was a founding faculty member of Texas A&M Law School, which began as the Dallas/Fort Worth School of Law in Irving in 1989 and named Texas Wesleyan University School of Law in 1992, where he was instrumental in

chartering the Spurlock-Armstrong Student Senate of Delta Theta Phi; and

Whereas, Judge Joe Spurlock II was a beloved law school professor who demonstrated a commitment to teaching law and motivating his students with such dedication that many strive to be like him because of his nature to grow, innovate, and inspire others; and

Celebrating Lanny S. Vines

Litigator. Brother. Philanthropist. Trailblazer. Are only just a few of the adjectives used to describe Lanny S. Vines. Our outstanding brother passed away on December 9, 2020, at the age of 80.

In 1966, Lanny S. Vines received his Juris Doctorate from Birmingham School of Law while serving as a Bailiff for the Honorable Judge Cecil Deason in the Jefferson County Circuit Court.

He served our country in the National Guard for two years. Lanny founded and was partner at Emond & Vines law firm, Emond Vines Gorham & Waldrep law firm, and later at Lanny S. Vines & Associates law firm. He was widely known for his dedication to his clients and the diligent pursuit of legal claims on their behalf.

In fact, Mr. Vines was known for working more than 12 hours a day, seven days a week, and was usually only sustained by one large meal per day. He slept only about four hours a night. When not at the office, he was in court; the hands-on litigator preferred to advocate in person.

During his career, he was known for representing consumer class-actions and catastrophic injury cases, as well as companies and government agencies, which included Homewood and Pelham, Alabama, among his municipal clients, Jefferson County and Alabama personnel boards, the Birmingham Board of Education, the Birmingham Water Works Board, and the Birmingham-Jefferson Convention Complex.

When he was not in court, he was serving in leadership positions within the legal community including as Past President and Board of Governors of Alabama Association for Justice (formerly Alabama Trial Lawyers Association), and with the Trial Lawyers for Public Justice.

Former Dean of Birmingham School of Law, James Bushnell, II, said, "Lanny Vines was a formidable and respected member of the Alabama Bar, who represented individuals seeking civil justice. His presence will be missed."

Not to be outdone by his work in the courtroom or in the many legal organizations in which he held leadership positions, was his charitable work. He contributed millions to Alabama charities and community organizations throughout his lifetime. Among the benefactors included the Alabama Symphony Orchestra, the Birmingham Museum of Art, the Birmingham Opera Guild, the Greater Birmingham Humane Society, the local chapters of the American Cancer Society, the Salvation Army and the

United Negro College Fund, Lanny S. Vines Award at Birmingham School of Law, the Herbert W. Peterson Trial Advocacy Endowed Scholarship at Cumberland School of Law and the Lanny S. Vines Endowed Scholarship at the University of Alabama School of Law in order to provide financial assistance to students attending law school.

The Vines Senate was chartered in 1992 at Birmingham School of Law under the namesake of Lanny S. Vines. As a student, I had the honor to serve as Vice-Dean of the Vines Senate, was a Scholarship Certificate and Key recipient and was named Student of the Year in the Region for the 2016–2017 academic year. None of those accolades would have been possible without the trailblazing that occurred by brother Lanny Vines. His commitment to Delta Theta Phi Law Fraternity paved the way for future generations of brothers and sisters.

"Lanny is a guy who has never forgotten where he came from," former law partner, Charlie Waldrep said. "He pulled himself up by his own bootstraps, and he dedicated himself to helping people in and out of the courts. But he will not make a big deal out of it. There are a lot of scholarships and funds out there in other people's names thanks to him."

The mission of the Delta Theta Phi Law Fraternity is, "To foster lifelong friendships and professional affiliations through legal education, international networking, and mutual respect." That is exactly what Lanny Vines dedicated his entire career to. Well done, brother Vines.

Before the pandemic began, the student senates were hard at work planning and executing a variety of activities for its members.





1969 TO 2019—A DELTA THETA PHI REUNION

In 1969—a year marked by memorable events including a moon landing, a rock and roll concert at Woodstock, Manson murders in L.A., and a political scandal that began on Chappaquiddick Island—five young men, graduates of the University of Texas law school in Austin, were sworn in as new members of the bar. Four of those men were also law fraternity brothers. Two of them grew up together in Lufkin, a small town in East Texas.

Bill Dennie Cook and Lee Mathews started school together in 1950 at Lufkin’s Central Ward Elementary. They graduated from Lufkin High School, then from law school in 1969, and stood side by side at their swearing in by the Texas Supreme Court. Also graduating with them in 1969 were Lee Yeakel (Austin, Texas), Jack Enos Cole (Fort Worth, Texas), and Charlie Tupper (El Paso and now Dallas).

In June 2019, all four men reunited at the State Bar Of Texas’ annual meeting in Austin, where


