4. Release and Waiver of Liability

To the fullest extent permitted by law, Participant, on behalf of themselves and their heirs, assigns, personal representatives, family members, and estate, hereby releases, waives, discharges, and covenants not to sue the Delta Theta Phi William B. Lawless Senate, Delta Theta Phi, International, along with its officers, members, organizers, representatives, volunteers, agents, and affiliates (collectively, the “Released Parties”), from and against

any and all claims, demands, causes of action, liabilities, damages, losses, costs, or expenses of any kind, whether known or unknown, arising out of or related in any way to:

- Participant's travel to or from the event,
- Participant's stay at Hotel FERA,
- Participant's attendance at any listed or related activity,
- Participant's presence at any on-site or off-site venue,
- acts or omissions of third parties,
- and any injury, illness, death, loss, or property damage occurring in connection with the event,

except to the extent caused by the gross negligence or willful misconduct of the Released Parties, if such liability cannot be waived under applicable law.

5. Third-Party Venues and Services

Participant understands and agrees that the Organization does not own, operate, or control Hotel FERA, Disneyland, the baseball venue, transportation providers, food vendors, or other third-party venues or service providers associated with the event. Participant further understands that the Organization is not responsible for the acts, omissions, conditions, policies, security, operations, or negligence of such third parties.

6. Personal Responsibility

Participant agrees to exercise reasonable care for their own safety and wellbeing, to comply with all venue rules, hotel policies, event instructions, and applicable laws, and to arrange for their own medical, travel, and property insurance if desired. Participant is solely responsible for their own personal belongings, transportation arrangements unless otherwise expressly provided, and personal decisions made during the event.

7. Medical Authorization and Emergency Care

In the event of illness or injury, Participant authorizes emergency medical treatment deemed reasonably necessary if Participant is unable to give informed consent at that

time. Participant understands that the Organization does not assume responsibility for providing medical insurance or payment for medical treatment, transportation, or related expenses.

8. Indemnification

Participant agrees to indemnify, defend, and hold harmless the Released Parties from and against any claims, demands, damages, liabilities, losses, costs, or expenses, including reasonable attorneys' fees, arising out of or related to:

- Participant's acts or omissions,
- Participant's violation of venue rules or law,
- Participant's injury to another person,
- or damage to property caused by Participant.

9. No Reliance; Independent Participation

Participant acknowledges that participation is voluntary and that they have had the opportunity to ask questions and seek independent legal advice before signing this Agreement. Participant is not relying on any oral statements or representations not contained in this Agreement.

10. Governing Law and Severability

This Agreement shall be governed by and interpreted under the laws of the State of California. If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

11. Binding Effect

This Agreement shall be binding upon Participant and Participant's heirs, next of kin, family members, estate, executors, administrators, and personal representatives.

12. Acknowledgment of Understanding
